Sabbatical



I am immensely grateful that the Vestry has supported and helped to make arrangements for a sabbatical leave for me this summer. Peter and I will be spending July through September in Scotland. Sabbatical time is defined as a period of refreshment and reflection for clergy (and other professions as well). A sabbatical generally includes an educational component, which mine will. I have chosen a residential seminar for contemplative learning from the Celtic Christian tradition called the Céile Dé. The time will be spent in silence, meditation, and learning, as well as time out in the beauti-

ful presence of God in nature. For the rest of the time, Peter and I will be exploring the Scottish countryside, visiting places like Iona, the birthplace of Celtic Christianity, the misty and mysterious Highlands, and taking time for us.

Sabbatical is also a time for congregations to reflect on the shared ministry with their clergy. I will be doing a lot of praying, seeking guidance from God and hopefully listening to hear what an answer might be to the question, "What are we as Trinity Church supposed to do in this anxious and troubled world?" The one answer that I know I will not hear is that we should stay exactly as we are and do what we have always done. The societal forces that are aligned against congregations are too strong to be able to survive without congregations willing to be made new. Ann and Vestry members will host conversations with the congregation, which I encourage everyone to participate in. I ask that you take the next three months to pray and wrestle with our circumstance, so that we might discern our direction together when Peter and I return.

Trinity will be well cared for by three different priests. In July, The Rev. Dr. Pam Tyler will be with you. Pam is an old friend from California, now living in Florida. The prospect of a New England July was enticing enough to bring her here. In 2007 Pam officiated at Peter's and my wedding. Pam has done a lot of work with IRIS in Los Angeles, and since that time created and ran a beautiful retreat center in Taos, New Mexico, before retiring to Florida.

The Rev. Dr. Ann Broomell is a bit more local. She has returned to Connecticut after serving in Florida and as the Dean of Trinity Cathedral in Easton, Maryland. Most recently, Ann has served as the Interim Rector at Christ Church in New Haven. We are fortunate to have found a break in her busy schedule. She will be with you during the month of August. Both Pam and Ann will be available to Trinity beyond the Sunday services, helping with Pastoral Care and administrative functions.

In September, Sunday services will be led by The Rev. Jane Stickney, who has been with you all before. Jane served as the Vicar at St. John's in North Guilford, and as a mentor to Episcopal students at the Yale Divinity School.

While there are no weddings scheduled for this summer, funerals happen when they will. Should the need arise for a funeral during my absence, Pam and Ann will be available during their respective months. The Rev. Harlon Dalton will be available during September. Asking former clergy to return for such services is prohibited in a newly formulated diocesan policy (April 2016. See link on e-blast). Having these three lovely and pastoral priests prepared to be present should such the need arise will keep us in accordance with policy and make sure that all are well cared for. If you have any questions about this, please don't hesitate to call me before July 5th.

A death in our parish family is one of the few things about which I will be informed while I'm away. I will do my best to be in contact and helpful, while fully confident in the gifts and skills of Pam, Ann, and Harlon.

We are also blessed to have wonderful parish leadership that will help to see Trinity through anything that might arise in my absence. Jane will be in the office as usual, coordinating everyone and the calendar of activities. Wardens and Chairs will be on-the-job as always. Ann Freeman will check my email frequently. In short, everyone you might need is accessible to you, as always.

It was only recently, as I thought about my impending departure from Trinity and from New England (for college at American University in Washington, DC), that I realized

my ("planned") future was not a separation from my times here, but a direct reflection of what I did at this church.

It was behind this lectern that I learned it was possible to be a public speaker and a stutterer, that talking for many people at a time was something I liked to do. My recent work at WNPR, and my plans to get involved at WAMU (AU's NPR member station) and NPR in Washington, would not have been formulated without our lectern.

Stewardship Ministry

Lower Level Renovation Project

This important initiative is progressing. A joint meeting, including Vestry members, Steering Committee members and the architect of choice, Tony Terry, helped to clarify the project and the purpose of the feasibility study. Parishioners were also invited to hear the details. Vestry voted unanimously at the June meeting on using \$30,000 of Trinity's money to pay for the Feasibility Study.

On a practical level, in the last week we have received another two requests for use of our space by non-profits in town. Meeting space is at a premium. With all the recent and planned housing units and retail shops added around the downtown area, there are more people, more activities, in our immediate neighborhood. Experts say Millennials have a different approach to most things, compared to most of us reading this newsletter. Rental housing and rental space is what they will be looking for. That could be Trinity.

Mid-year Giving Statements

Statements will be going out in July. Watch for advance warning to expect receipt by email for everyone with an e-address. It's another step in time-saving and expense reduction. Good stewardship of our resources! Anybody who prefers to receive by mail, should contact the office. It's just one click to make that happen along with others mailed for people who don't use a computer.

Year-to-Date Financials

Overall, on the income side we are 12% below where we expected to be at this point. We are studying this to better understand the cause(s). On the expense side, \$24,000 for expected small capital projects has not been spent. Our good fortune helps offset the revenue shortfall.

Endowment Fund Committee Progress

Finance Ministry

This Committee continues to meet to finalize the annual process to calculate, track spending, and report use of available fund dollars, according to restriction or general use. Available dollars are calculated using a spending rule which ranges from 3%-5% as determined by the Committee suggestion and Vestry's ultimate approval. Maximum dollars available for 2016 are \$66,203. Of that amount, \$49,000 is expected to be needed towards meeting operating expenses. The increased amount of the operating shortfall is, in part, due to the loss of the annual \$15,000 grant for operations from the Foote Family Charitable Trust. Instead, the Trust awarded Trinity \$73,000, but restricted it to capital improvement projects. Removing the restriction on future grants will be discussed with the Executor.

Mabel Shepard Will

We are grateful to Jay Pottenger, who has applied his legal expertise to research and clarify the ambiguous language in Mabel Shepard's Last Will & Testament, which was executed in January 1971; she died in September, 1984. Jay spent time at the Probate Court reading through the files of lawyer Don Sawyer who drew up Ms. Shepard's Will.



The Shepard Will asked that the proceeds of selling her home and adjacent lot be spent in the discretion of the Trustees (the Rector and Sr. & Jr. Wardens of Trinity Church, Branford): (i) "for welfare work within the parish of said Church" or (ii) if the trustees deem it "inadvisable to spend all for that purpose, then for providing scholarships for needy and deserving students within the parish of said Church". The phrases requiring interpretation are "welfare work"; "needy and deserving students"; and "within the parish of said Church" [which applies to both uses].

Jay's research suggests that "welfare work" has a broad meaning, reflecting the long-standing concept of "general welfare" of the community or body politic, as recited in the founding documents of the United States. The pejorative connotation of "welfare" as a negative social program targeted to the poor seems to have gained prominence some years after the Will's execution. The phrase "within the parish of said Church" most likely reflects the concepts of community and membership, which are consistent with that broader, communitarian notion of "welfare". It is unlikely that the reference to "parish" was intended in the ancient English sense of a geographical boundary or district, since that usage was tied to the English political context, with an established, official "state church", in

which each church served a specific village or district. [John Seibyl, who served as Trinity's Senior Warden in the midnineties, said at that time these phrases were interpreted to extend both to those in need outside of our congregation as well as Trinity members.]

The phrase "needy and deserving students" seems to leave considerable discretion with the Trustees; given the spiraling costs of education, it is difficult to say that a particular student is neither "needy" nor "deserving".

Education Scholarships Available, But Changed

Historically, education scholarships received through Trinity have been known as Shepard Scholarships, since

the funds came from the Mabel Shepard Fund. Through the work of current Finance Ministry members and members who are legal experts, it was discovered that scholarship use was the secondary purpose within Mabel Shepard's Will, not the primary purpose. The primary purpose, as outlined by Jay Pottenger's findings on page 6, is a much broader general use which would benefit a greater number—if not all—of the members. It remains at the discretion of the Trustees and Vestry how much of the available Shepard money is spent on general use benefit vs. scholarships. That will be determined annually by current priorities.

New this year, money for scholarships could also be available through the Goodrich Fund, given the daunting cost of education. The Trustee is Mike Dodd and the Probate Court. The combination of Shepard and Goodrich funds for scholarships continues the tradition of supporting scholarship gifts at a level that is helpful. These many years after Mabel's death, the education system has changed greatly, with students engaging at any time of life, and thus there is no shortage of applicants. We are pleased that Trinity can meet the challenge, and feel confident both Mr. Goodrich and Ms. Shepard would be pleased.

New applicants should complete the application form and forward to **juniorwarden@trinitybranford.org by July 15.**Returning applicants will shortly receive an email with instructions.
